- [maincubes confirms EU Taxonomy alignment for BER01 \(Berlin\)](#), following its earlier FRA02 alignment (2024). This is a notable signal for EU-focused capital seeking taxonomy-aligned digital infrastructure exposure.
- [OVHcloud backs University of Strasbourg's bgproutes.io BGP research](#), providing compute, hosting, Bare Metal and network-engineering support for large-scale route collection, real-time visualisation and anomaly detection.
- [Cipher Mining sets date for Q4 and full-year 2025 results](#) (release before market open on 24 Feb 2026; call/webcast at 8:00 a.m. ET). For investors, this is a near-term catalyst for disclosure on bitcoin-mining data centre and HPC hosting operations.

Compute architecture / energy efficiency research

- [Near-Storage Processing Boosts Offline Inference for Long-Context LLMs](#): authors introduce **HILOS**, a near-storage processing framework that offloads attention operations to near-storage accelerators.
 - Reported results (on a system with **16 SmartSSDs**): up to **7.86x throughput** and up to **85% reduction in energy consumption** (offline inference, long-context LLMs).

2-line close

Today's set was dominated by Europe-facing sustainability verification and network-resilience research support, with limited new information on grid access or power contracting. Near-term investor attention may skew to scheduled earnings disclosures and cloud platform capability rollouts.
